**Subject:- Provisional Shortlist of Candidates to be called for Interview for the post of Class-IV under RBA-(State Cadre) advertised vide Adv. Notice No. :- 01 of 2018 Dt. 12-07-2018.**

1. Whereas, the Legal Metrology Department, vide its Advertisement Notice No. 01 of 2018 dated 12-07-2018, invited applications from the permanent residents of Jammu & Kashmir State for recruitment to **One** post of Class IV under **RBA Category-(State Cadre)** in Legal Metrology Department, Govt. of J&K;
2. Whereas, 30-days time from the date of publication of advertisement notice was given for submission of applications from the candidates;
3. Whereas, in response to the above Advertisement Notice, the Department received a total of 105 applications with a breakup of 36 applications from Jammu Division and 69 applications from Kashmir Division;
4. Whereas, as per standing rules, the candidates are required to be shortlisted for interview on the basis of merit of candidates in the prescribed qualification;
5. Whereas, accordingly it has been decided that the process of short-listing shall be followed according to the following criteria:-
  1. **Ratio to be followed = 1:5 (Five candidates for one post).**
  2. **Weightage to Marks Obtained in Matric (10th) Class = 60 Points on pro-rata basis.**
  3. **Weightage to Marks Obtained in 12th Class = 20 Points on pro-rata basis.**
6. Whereas, in accordance with the above criteria the following number of candidates are required to be called for interview in the ratio of 1:5 for **One Post under RBA-category;**

7. Whereas , the final cutoff merit for Provisional Shortlist calculated on basis of above fixed criteria remained at **69.78**.

Now, therefore, the Provisional Shortlist of the candidates purely on the basis of merit obtained in prescribed qualification and strictly as per laid down criteria is hereby annexed as **Annexure-A** to this notification for information of the candidates which is also available on the Departmental Website [jklm.nic.in](http://jklm.nic.in). Any of the applicant(s), if aggrieved with the Provisional Shortlist can represent in the **Office of the Controller, Legal Metrology Department, Govt. of J&K, SDA Colony, Bemina Srinagar** along with the proof of his/her claim(if any), for necessary rectification within a period of 21 days from the date of publication of this notice. After the said period, no claim/objection whatsoever, shall be entertained.

Moreover, **the interview schedule of the short-listed candidates shall be notified separately.**

**Note:-** The short-listing of the candidates is purely provisional and subject to further verification of their testimonials. Any candidate who is found to have provided wrong/misleading information in the application form and figures in the shortlist, on the basis of such false information his/her candidature for the interview of the said post shall stand cancelled abinitio and appropriate action as envisaged under rules shall be initiated against him/her.
