Whereas, objections, were invited from the concerned regarding the positions assigned to them within a period of 20 days from the date of issuance of the said tentative seniority list; and


Whereas, objections have been received from following employees: -

1.	Mr. Rajinder Singh (Senior Assistant)	Claiming initial appointment of Mr. Sachin Bharti as backdoor.
2.	Mr. Sachin Bharti (Senior Assistant)	Claims his seniority to be shown over and above Mr. Rajinder Singh.

Whereas, these objections have been examined in light of the rules and relevant records and accordingly disposed as follows: -

S. No.	Name of the Official	Objection	Grounds on which objection Disposed Off
1.	Mr. Rajinder Singh (Senior Assistant)	Claiming initial appointment of Mr. Sachin Bharti as backdoor.	After perusal of records, it was revealed that Mr. Sachin Bharti has been promoted as Junior Assistant vide office Order No. LM-17 of 2005 dated 31-03-2005 and subsequently as Senior Assistant vide office Order No. 12-LM of 2017 dated 22-02-2017, by the Departmental Promotion Committee and no objection challenging his initial appointment had been received. Thus the objection raised by Mr. Ranjinder Singh is devoid of any merit and disposed off accordingly.
2.	Mr. Sachin Bharti (Senior Assistant)	Claims his seniority to be shown over and above Mr. Rajinder Singh.	After perusal of records, it was revealed that the services of Mr. Ranjinder Singh have been adjusted/absorbed as Senior Assistant instead of Mechanic w.e.f. 03-07-2009 in pursuance to Govt. Order No. 07-FCS&CA of 2017 dated 18-01-2017 . Whileas Mr. Sachin Bharti has been promoted as Senior Assistant w.e.f. 11-11-2016 vide office Order No. 12-LM of 2017 dated 22-02-2017 . As such the objection raised by of Mr. Sachin Bharti cannot be considered as Mr. Rajinder Singh has been accorded the effect of Senior Assistant w.e.f. 03-07-2009 i.e. much before Mr. Sachin Bharti was promoted as Senior Assistant.
