WHEREAS, aggrieved of the decision, the above mentioned I/c Manual Assistant G-I who were figuring over and above the Manual Assistant G-II approached the Hon'ble CAT which passed directions, the operative part of which is as under:-

"In view of the limited prayer made by the learned counsel for the applicants, the O.A is disposed off with the direction to the respondents to consider the case of the applicants for

promotion to the post of Manual Assistant G-I in accordance with the communication dated:- 03.12.2020 within a period of one month from the date of receipt of certified copy of this order”;

WHEREAS, in compliance to the directions of Hon’ble CAT, the DPC again met on 23.03.2021 and decided to keep the decision withheld on the plea that vigilance clearance of the officials was not available as the same had expired and recommended that a fresh vigilance clearance be sought from GAD for placing their case in next DPC and;

WHEREAS, fresh vigilance clearance from GAD and other relevant documents viz. APRs for last three years, Work & Conduct and Integrity Certificate were sought and;

WHEREAS, DPC meeting was again held on 13.10.2021 wherein the case of I/c manual Assistant grade-I was placed before the committee for confirmation and;

WHEREAS, DPC examined the documents viz. Vigilance clearance, APRs for last three years, Work & Conduct and Integrity Certificate threadbare and recommended confirmation of following I/c Manual Assistant G-I as Manual Assistant G-I in the Pay scale of Rs (5200 – 20200) + 2400 (Pre-Revised) Level – 4 of Rs 25500- 81100 (Revised) notionally w.e.f 19.10.2018 i.e. the date of accrual of clear vacancy and from the date the incumbents were placed as I/c Manual Assistant grade-I and monetarily w.e.f 13.10.2021.

WHEREAS, DPC re-examined the decision taken in the DPC meeting held on 26.08.2020, wherein 05 Manual Assistant G-II were recommended for promotion as Manual Assistant G-I in the pay scale of Rs (5200 – 20200) + 2400(Pre-Revised) Level – 4 of Rs 25500- 81100 (Revised) notionally w.e.f 01.03.2020 and monetarily w.e.f 26.08.2020;

WHEREAS, after re-examining the records and other relevant documents, the committee observed that the 05 Manual Assistant G-II were figuring below in the seniority list and were not even placed as I/c Manual Assistant G-I i.e. from the date they have been given the effect of notional promotion w.e.f. 01.03.2020 prior to their promotion;

WHEREAS, the committee reviewed the decision taken in the DPC meeting held on 26.08.2020 and decided that promotion in respect of these Manual Assistant G-II shall take effect from 26.08.2020 i.e. the date they were promoted as Manual Assistant G-I with monetarily benefits which is in line with the Instructions passed by the government in terms of Government Order No.743-GAD of 2007 dated 28.06.2007.

Now, therefore, in view of the above stated facts, sanction is hereby accorded to the confirmation/promotion of following I/c Manual Assistant G-I and Manual Assistant G-II as Manual Assistant G-I in the pay scale of Rs (5200 – 20200) + 2400 (Pre-Revised) Level – 4 of Rs 25500- 81100 (Revised) notionally and monetarily as indicated against each:-
