3. The candidate(s) who fail to appear in the interview on the scheduled date and time shall not be considered for further selection.
4. The candidates have been included in the interview list provisionally and only such candidates shall be allowed to appear in the interview who are within age, possess valid prescribed qualification and valid category certificates issued before cut-off date.
5. The additional qualifications/reserved category certificate acquired by the candidate after the cutoff date of application forms shall not be entertained.
6. Mere figuring of name in the list does not entitle a candidate to appear in the interview as it shall be subject to the scrutiny of all testimonials of the candidates shortlisted.
