**ORDER No. :- 44 - LM OF 2019**  
**DATED :- 22 - 02 - 2019**

**Whereas**, applications were invited vide Advertisement No. 01 of 2017 dated 08-12-2017, from permanent residents of State, for recruitment against 05(OM=03, RBA=01 and ST=01) Class-IV posts of Jammu division;

**Whereas**, a committee of Officers of Legal Metrology, was constituted to scrutinize the application forms received against the above mentioned advertisement;

**Whereas**, the documents with respect to the bio-data, academic merit and category status of all applicants was scrutinized by the committee and the shortlist was issued vide No. LM/C-Esstt./03/2013 dated 26-06-2018;

**Whereas**, the Department on the basis of shortlist of the candidates already issued decided to conduct Interviews and fixed the date for conducting the Interviews on 12-02-2019;

**Whereas**, in the meantime, the scrutiny of the documents submitted with the application forms of shortlisted candidates was started and while examining the Excel database of applicants after adding Date of Birth Column in the shortlist, for calculating age as on 01-01-2017, it was found that there are errors w.r.t. Date of Birth entries made and Marks Obtained of some shortlisted candidates. Besides some complaints were also received through E-mail, mentioning that some candidates who were underage i.e. below 18-years as on 01-01-2017, have been shortlisted. The facts were checked viz-a-viz documents of said candidates and the claims were found to be genuine;

**Whereas**, taking cognizance of the factual position, the Interviews scheduled on 12-02-2019 were postponed.

Now, therefore, a committee of following Officers is constituted to re-examine and scrutinize all the applications viz-a-viz bio-data, academic merit and Date of Birth etc. for ascertaining their eligibility for the said Class-IV posts as on 01-01-2017 and prepare the Merit List afresh:-
