Whereas, after expiry of the time period i.e. 30 days the Department received 1081 no. of applications; and

Whereas, as per standing rules, the candidates are required to be shortlisted for interview on the basis of merit of the candidates strictly as per their qualification; and

Whereas, a Committee headed by Joint Controller, LMD Jammu was constituted vide Order No.19 - LM of 2018 dated 02.03.2018 for scrutinizing the applications forms strictly as per the eligibility condition laid by the General Administration Department; and

Whereas, the Committee after scrutinization of application forms, eligibility criteria, furnished the merit list vide communication no. LM/JCJ/34/2018 dated 17.04.2018; and

Whereas, as per the laid down criteria the following no. of candidates are required to be shortlisted for interview: and


1. Ratio to be followed = 1: 5 (Five candidates for one post).
2. Weightage to basic qualification (10th) = 60 Points on pro rata basis.
3. Weightage for higher qualification (12th) = 20 Points on pro rata basis.


