Sir,

This is in reference to the subject cited above in this context as has been requested earlier vide this office communication No. LM/C-Estt/12/2017 dated 16-11-2020 that this office may be communicated about the reasonable date on which the Departmental Promotion Committee (DPC) can be convened. Accordingly as per the telephonic conversation held with you on 27-11-2020, it was decided that DPC in respect of I/C Manual Assistants Grade-1 shall be fixed in the 2nd week of December preferably on 8<sup>th</sup> of December 2020. However, due to the recent developments in the Legal Metrology Department, it emerged that In-charge Manual Assistants Grade-1 have challenged the basic DPC conducted on 26-08-2020, before the Central Administrative Tribunal (CAT), UT of J&K. In these premise it is here by informed that the DPC for confirmation of I/C Manual Assistants Grade-1 cannot be conducted till outcome of decision from the Hon'ble CAT-UT of J&K
