

1. **Whereas**, Shri Choor Singh, R/o Kanthi District Ramban, P.O Chanderkote, PIN 182148, J&K had filed an RTI application dated 26/11/2020 which was transferred by Deputy Director, Legal Metrology, Govt. of India, New Delhi to PIO in this office and received in this office on 15-12-2020 and
2. **Whereas**, Application was forwarded by this office to Joint Controller, Legal Metrology, Jammu vide letter No. LM/C-RTI/08/2020 dated 18-12-2020 and subsequently forwarded to Deputy Controller Legal Metrology , Enforcement , Jammu with the direction to provide the requisite information directly to the applicant.
3. **Whereas**, the application was replied to by the Deputy Controller, Legal Metrology, Enforcement, Jammu vide letter No. LM/DC-Enf/165-167/2020 dated 24-12-2020 as under:-

“The monitoring of Gold rate is not in the purview of this Department.”
4. **Whereas**, Shri Choor Singh, R/o Kanthi District Ramban, P.O Chanderkote, PIN 182148, J&K filed first appeal with registration No. DOCAF/A/E/21/00012 dated 06/02/2021 before appellate authority (Director , Legal Metrology, Govt. of India) which was received in this office on 17-02-2021 expressing therein that no reply was received by him in respect of his original RTI application dated 26-11-2020.
5. **Now**, while going through the records, it has been observed that the information has been already provided by the Deputy Controller, Legal Metrology, Enforcement, PIO, Jammu vide letter No. LM/DC-Enf/165-167/2020 dated 24-12-2020 through ordinary post and also vide letter No. LM/DC-Enf/206-208/2021 dated 19-02-2021 through registered post and on email of the RTI applicant and was found appropriate and in order.

With above order, the Appeal stands disposed off.
